DEADLINE FOR FILING PETITIONS IS AT 5:00 P.M. on JUNE 27, 2022.

ATTENTION: Please read as changes have occurred:

1. On 1-27-2020, Tribal Council approved to have the CRST Law Enforcement charge \$15.00 per fingerprints. Therefore, the Candidate would need to pay \$15.00 to the CRST Law Enforcement prior to completing the fingerprints. Once fingerprints are completed, bring the fingerprint card to the Tribal Secretary's Office.
2. On 2-19-20, Tribal Council approved of Ordinance 14-Elections and therefore approved to have the candidates pay a \$27.00 filing fee to the Disbursing Office and bring receipt to the Tribal Secretary's Office.
3. In accordance with Ordinance 14 – Elections, Part 5, Section A, #8: Adherence to Tribe's Drug Testing Policy, Page 25: Each Candidate will pay a drug test fee of \$25.00 and submit the drug test result to the Tribal Secretary's Office. Tribal Council approved the drug testing fee on 1-27-20. Applicant may utilize the CRST Law Enforcement for the drug test.

Therefore, the Petition shall be accompanied with the following: a receipt for payment of the \$27.00 filing fee; completed Candidate's Certification of Qualification Form; fingerprints for a background check, a receipt for payment of the \$15.00 fingerprint fee; drug test results, a receipt for payment for the \$25.00 for the drug test fee and other qualifications for candidacy upon submission to the Tribal Secretary's Office. The Tribal Election Board shall certify the petitions. Note: The candidates of Officers-At-Large are required to furnish proof to the Tribal Election Board that in the event they are elected to Office, they will be able to furnish satisfactory bond.
