DISTRICT DEPUTY/FOOT PATROL

DESCRIPTION OF WORK

General Statement of Duties: Patrols the Housing area in the Communities as well as where there may be government buildings or government property. Monitors community for any violations, mainly curfew violations. Reports to Law Enforcement police officers/ dispatchers any disturbances requiring police attention.

Supervision Received: Works under the general supervision of Lieutenant of Police.

Supervision Exercised: None.

EXAMPLE OF DUTIES (Duties may include but are not limited to the following):

Carries out orders of the Sergeant on Duty.

Reports verbally and in writing violations of the Law & Order Code.

Makes NO ARRESTS.

Assists Police Officers in their work as needed or assigned.

Must have a knowledge of the Tribal Law and Order Code, all other laws and regulations applicable to the reservation. Will attend such training sessions as the Chief of Police may direct.

Must maintain a drug and alcohol free lifestyle and adhere to CRST drug policy. Refrains from engaging in any behavior which would reflect discredit on the Tribe or Tribal Police Department.

Refrains from the use of profane, vulgar, insolent or any type of offensive language during tour of duty.

Keeps all equipment furnished by the Tribe or the government in good repair and order immediately reports the loss of any such property.

Obeys all regulations which the Chief of Police may adopt and perform related work as required.

Must maintain confidentiality

Must obtain certifications for any type of additional use, such as Mace, zip tie usage, etc.

Must maintain professional appearance at all times and wear assigned uniform/equipment.

MINIMUM QUALIFICATIONS

Required Knowledge, Skills and Abilities: Ability to cope with extreme situations. Ability to deal courteously with the public. Ability to communicate effectively in writing and orally. Ability to be fair and impartial. Ability to perform work requiring, good physical condition. Must possess a valid driver's license, reside in the community.

Education: High School Graduation or GED.

Experience: Past security experience and/or foot patrol preferred.

Special Requirements: Must be 18 years of age. Must have a current physical (attach document). Incumbent is subject to the CRST Drug & Alcohol Testing Policy; must pass pre-employment drug screening and will be subject to random drug screenings (will be required to sign and submit a form understanding and receiving policy). Must be able to pass local/Tribal, Federal and State background checks in accordance with P.L. 101-630, P.L. 101-647, and Resolution No. 86-2013-CR (will be subject to submit and pass these checks every five (5) years).

Must not have been convicted of any domestic violence, or any crimes against children or elderly.
